A settlement has been reached in a class action lawsuit alleging that Real Good Foods, LLC (“RGF”) sent telemarketing text messages to wireless telephone numbers after the recipients had requested to be opted out, in violation of the Telephone Consumer Protection Act, 47 U.S.C. § 227. RGF denies the allegations and any wrongdoing. The Court has not decided who is right.

Who’s Included? You received this postcard because Defendant’s records show that you may be a Settlement Class Member. The Settlement includes “All persons within the United States who, within the four years prior to the filing of this Complaint, (1) were sent a text message from Defendant or anyone on Defendant’s behalf, (2) regarding Defendant’s goods, products or services, (3) to said person’s residential telephone number, (4) after making a request to Defendant to not receive future text messages.

What Are the Settlement Terms? Defendant has agreed to make either up to \$8.25 in cash or up to a \$25 voucher for the purchase of Defendant’s products per class member available to the Settlement Class, which will be used to pay individuals who submit valid Claims, attorneys’ fees, and Service Award to the Class Representative. The cash payments, which are up to \$8.25 or vouchers of up to \$25.00 (which can be used to purchase Defendant’s products), less Notice and Administration costs, Attorney’s Fees and costs, and Service Award, from the Settlement Fund will be distributed to Settlement Class Members who submit a valid Claim. One Claim is allowed per Settlement Class Member.

How Can I Get a Payment? To get a payment, you must submit a valid Claim Form by U.S. mail or via email to claims@CassidyTCPAclaimssettlement.com or file a claim online at www.CassidyTCPAclaimssettlement.com. A Claim Form is attached to this notice. You may also download a Claim Form online at www.CassidyTCPAclaimssettlement.com or call the Settlement Administrator at the toll-free number below to request a Claim Form. To be valid, a Claim Form must be completed fully and accurately, signed under penalty of perjury, and submitted timely. If you send in a Claim Form by regular mail, it must be postmarked on or before **July 30, 2024**. The deadline to file a Claim online or via email is **11:59 pm. EST on July 30, 2024**.

Your Other Options. If you do not want to be legally bound by the Settlement, you must exclude yourself by **June 25, 2024**. If you do not exclude yourself, you will release any claims you may have, as more fully described in the Settlement Agreement, available at the Settlement Website. You may object to the Settlement by **June 25, 2024**. The Long Form Notice available on the Settlement Website listed below explains how to exclude yourself or object. The Court will hold a Final Approval Hearing on July 15, 2024 at 10:00 a.m, to consider whether to approve the Settlement, a request for attorneys’ fees and costs of up to \$400,000 plus expenses, and a Service Award of \$10,000 to the Class Representative.
